 \gg In its letter to you dated 6 December 2001, the AMC advised that, in relation to its assessment of your application, the Royal Australian and New Zealand College of Psychiatrists found a discrepancy between your claims of a professional qualification and the information provided by the issuing institution. A stated in the AMC's letter, this discrepancy will need to be satisfactorily resolved by the College and, more importantly, by the relevant State and Territory Medical Boards, before [conditional] registration can be granted. The AMC understands that no further information has been made available to assist the College in resolving this discrepancy. In the circumstances, it appears the College has been unable to process your application further.

Dear Sir/Madam,

I do hope that my specialist assessment has been finalised and an appropriate practical support, concerning my particular situation, offered.

Please, advise me officially by mail to PO Box 919, PALM BEACH, QLD, 4221.

Also, I have to notify you that as a result of contacting Russian authorities on my behalf by the RANZCP, my life was put in danger and I was forced to be in hiding outside Australia for some time. This created for me significant financial, psychological and moral difficulties.

I would like to stress again that I am a political refugee under Australian Federal Government protection. The abovementioned contact by the RANZCP has been made despite my written warnings and objections. This resulted in breaching the UN regulations, regarding refugees, and the Australian Privacy Act 1988, which put my life in danger.

Following an advice of my solicitor and some other agencies, I am considering an appropriate legal action against the RANZCP and AMC. Also, this matter can be reported to the UN, WHO, Australian Federal Government and mass media to prevent any similar illegal actions regarding refugees.

Yet, I am still feeling uncomfortable with a possibility of taking such actions against my colleagues. I do believe that the RANZCP and AMC apologies and assurance that a balanced and legal approach to refugee cases will be always employed, will resolve this matter.

I am looking forward to your wise and balanced approach to this matter.

I write to express my significant concern at the Medical Board's handling of matters surrounding Vincent Victor Berg.

It has come to my attention that the Medical Board was made aware in January 2002 that Vincent Victor Berg allegedly did not hold the primary medical qualifications he claimed in order to obtain registration in Queensland.

I am advised that you noted this was the case and did not seek to notify the Townsville Health Service District, which had been his sole employer during the period of his registration. It needs to be noted that Queensland Health employed Mr Berg on the belief that preliminary registration had been granted by the Medical Board.

We are now faced with the task of identifying all patients seen by Vincent Berg over the period of his tenure with the Townsville Health Service District to identify whether there has been any adverse outcomes for patients.

The time delay in finding out this information, which was only identified as an incidental remark in discussions with the College of Psychiatrists, has lead to significantly increasing the difficulty for the District and has potentially left patients at risk over a much longer period than was necessary.

I seek your explanation for the failure to notify the Townsville Health Service District and your undertaking that procedures will change within the Medical Board to ensure that we are notified of any significant issues in the future in a timely manner.

Further I seek your assurance that the Medical Board will be reporting this matter to the Police for investigation as a criminal offence.

Ministerial Brief - Vincent Berg

Berg wrote to the Board on 10 June 1999 seeking registration, preferably as a psychiatrist. He indicated he was prepared to update his clinical professional knowledge by undertaking postgraduate study and advised that:

- He was born in 1952 and had graduated with a Doctor's Degree in Psychiatry from the Medical Faculty of Voronezh State University (Russia) in 1977.
- He also claimed to have been awarded a PhD in Psychology and worked as a senior lecturer at the University until April 1982 and as a psychiatrist until August 1986.
- His medical career ceased in Russia when he was arrested by the KGB in August 1986 in connection with his political and religious beliefs.
- He arrived in Australia in December 1992, was granted protection as a refugee in October 1993, and subsequently gained permanent residency in 1994.

Berg had apparently been attached to the Gold Coast Hospital as a clinical observer and registration for this purpose was sought by the Gold Coast Hospital on 12 July 1999. At its meeting on 24 August 1999, the Board declined to approve conditional registration for Berg to work as a clinical observer at the Hospital on the basis that such an activity did not require registration.

On 29 September 1999, Townsville General Hospital, with the approval of the Chief Health Officer, appointed Berg to the position of Registrar – Psychiatry, subject to Berg obtaining registration with the Board.

On 13 December 1999, Berg applied for conditional registration seeking to undertake training in psychiatry at Townsville General Hospital. Conditional registration for this purpose, for a period of 12 months, was subsequently approved by the Board effective from 4 January 2000. A training program, nominating Dr John Allan FRANZCP as his supervisor, was received on 10 May 2000.

On 16 February 2000, Berg was given notice by the Board to explain discrepancies in his documentation within 14 days or his registration would be cancelled. A review of the file had identified that all claimed professional certificates were in fact in another name and had been manually altered to the name 'Berg'.

Documentation obtained from the Department of Immigration under Freedom of Information by Berg appeared to confirm that in 1996 he had declared a change of name from the name in the documents to the name 'Berg'. A decision was made by the Board not to pursue this matter further.

In July 2000, Berg complained to the Board regarding alleged inconsistencies in his circumstances compared to those of another unnamed overseas trained psychiatrist alleging discrimination. He was informed that the issue he raised should more properly be addressed by the Royal Australian and New Zealand College of Psychiatrists or his employer.

On 4 December 2000, Berg applied for conditional registration as a specialist psychiatrist in Queensland. He cited his qualification from Voronezh State University as the basis of his application. On 4 January 2001, the Board determined not to approve his application as the qualification was in a name other than the applicant's name and the qualification was in any case not recognized. It was also noted by the Board that with regard to the confirmation that Berg was one and the same person as the person named in the documents, the Department of Immigration had subsequently acknowledged that the Department would not have made enquiries relating to any qualification allegedly held by the person.

The Board determined that the Department be requested to make enquiries through the Moscow office as to whether the person named in the documents was in fact a graduate of the Voronezh State University in 1977. Berg was formally notified on 5 February 2001 of the Board's refusal of his application for conditional registration as a specialist (psychiatrist) and he was informed of his appeal rights. It should be noted that Berg's conditional registration to undertake training in this specialty was time limited and expired on 3 January 2001.

Berg wrote to the Board on 12 February 2001 seeking reconsideration but the Board reaffirmed its decision and suggested he submit his qualifications and experience to the Australian Medical Council for assessment by the Royal Australian and New Zealand College of Psychiatrists.

On 17 March 2001, Berg requested the Board issue a Certificate of Good Standing to the Northern Territory covering the period of his Queensland registration. Subsequently on 23 January 2001, the New Zealand Medical Board sought advice regarding Berg as he had sought registration in that country and on 31 July 2001 a further Certificate of Good Standing was sought by the Australian Medical Council, apparently in connection with the assessment of Berg's specialist qualification. In this regard, Berg had made an application to the Council for such an assessment as he had been advised to do by the Board on 12 February 2001.

While the Board had no proof that the qualifications relied on by Berg were fraudulent documents, it had sufficient concern not to issue a Certificate of Good Standing and in lieu only issued a Certificate of Standing. This is an indication to other regulatory authorities that the application should be carefully assessed.

The assessment undertaken by the Australian Medical Council, through the College, was extensive given the concerns raised by the Board and other regulatory authorities about the standing of the qualifications relied on Berg.

On 16 October 2001, the College wrote to the Australian Medical Council and the Boards advising that it had directly contacted Voronezh State University in an attempt to confirm Berg's qualifications. The University denied that the Certificates related to a graduate of that institution and stated that the documents were in fact forgeries.

There is no evidence that Berg has been registered in any Australian State or Territory since the College advice was received in October 2001.

It should be noted that:

- Berg was conditionally registered to undertake training in psychiatry at Townsville General Hospital from 4 January 2000 to 3 January 2001.
- The Board did not renew this conditional registration and refused Berg's application for conditional registration as a psychiatrist on the basis of its concerns about his documentation.
- The Board referred Berg to the Australian Medical Council for a detailed assessment of his qualifications through the Royal Australian and New Zealand College of Psychiatrists.
- The Board's concerns were subsequently confirmed 10 months later through the extensive assessment process undertaken through the Australian Medical Council by the Royal Australian and New Zealand College of Psychiatrists.

I write on behalf of the Fellowship Board Training and Examinations Exemptions Sub-committee regarding Dr Berg's application for specialist assessment/advanced standing. The Training and Examinations Exemptions Sub-committee formally considered this matter on the 20 September 2001.

Dr Berg stated in his application to the Australian Medical Council and the RANZCP, that he obtained his primary medical qualification (1975) and his Doctorate of Medicine in Psychiatry (1977) from the Voronezh State University in Russia. Dr Berg's submitted qualifications are in the name of Techkaline Victor Vladimirovich, which Dr Berg states in his Statutory Declaration dated 1 August 2001, he changed to Vincent Victor Berg.

As part of the standard RANZCP assessment process, applicants' overseas psychiatric qualifications are confirmed with the relevant College/University or Authority. The email address of the Voronezh State University in Russia was obtained via the internet and was contacted to confirm Dr Techkaline's qualifications in Psychiatry.

The Voronezh State University replied informing the RANZCP that they did not produce diploma number 723438 "Medical Degree in Psychiatry" and moreover the educational program stated was not in existence in 1977. The Voronezh State University requested faxed copies of Degree M-I No. 723438 "Medical Doctor in Psychiatry" and Degree MC XII No. 14211 "Candidate of Sciences in Psychology" for review, see attached email and facsimile to Sharon Rayner (trainee staff member) dated 10 and 17 September 2001.

After review of the faxed qualifications, Sergey Zapriagaev from the Voronezh State University emailed the College stating that the documents were crude forgeries, see attached email dated 11 September 2001. Faxed confirmation of this statement on Voronezh State University letterhead dated 17 September 2001, is also attached.



FRAUDULENT AND FORGED QUALIFICATIONS

Background

Two recent cases involving application for specialist assessment by overseas trained doctors have highlighted a potential problem with fraudulent or forged documentation. These problems have come to light as a result of the Specialist College seeking confirmation of the authenticity of the specialist qualification from the awarding institution.

In one case the applicant for assessment, Dr Vincent Berg, had been registered under an area of need provision in Queensland. The AMC understands that the registration ceased in January 2001 and that the doctor concerned is not currently registered in that State, but has applied for registration in another State. The entry in the NCMR is not flagged.

The Royal Australian and New Zealand College of Physiatrists (RANZCP), as part of its standard procedure with overseas trained specialists, sought confirmation from the Voronzeh State University that it had awarded a medical degree in psychiatry to Dr Berg. The response and subsequent correspondence from the University indicated that the documents submitted by Dr Berg were forgeries. The RANZCP informed the Medical Board on 16 October 2001.(See letter enclosed.)

Dr Berg has since complained that the College had no legal right to contact authorities in Russia, since he had entered Australia as a refugee and, under international conventions, Australia was bound to observe his request that no contact with his former country of residence should take place. Because of Dr Berg's threat of legal action, a teleconference was held on 15 January 2002 involving staff of the College, the AMC and the AMC's solicitor. The advice from Mr Topfer confirmed that there was no legal impediment to the College seeking confirmation of the authenticity of Dr Berg's qualifications. Consequently, the College has informed the Medical Board of Queensland and the AMC that on the basis of the information obtained from the awarding institution, it is not able to proceed with the assessment of Dr Berg's qualifications in psychiatry. (See letter of 23 January 2002.)

Implications for Registration

This case raises a number of assessment and registration issues:

- 1. Although the Specialist College or the AMC may be able to establish the *bona fides* of the qualifications submitted by applicants for specialist registration, they have no legal powers to pursue the matter further. The only option available to the AMC/Colleges is to suspend the assessment process. Any action to prevent the applicant from seeking registration in any other jurisdiction would require action by a State or Territory Medical Board under the relevant legislation.
- 2. In dealing with this case, and one other case involving the misrepresentation of qualifications in psychiatry, it is apparent that not all States may have the same powers under their legislation to deal with individual practitioners who

apply for registration using fraudulent qualifications. By way of example, the South Australian legislation enables the Medical Board to take action against a medical practitioner who has submitted fraudulent qualifications, wether that practitioner is currently registered or not. In Queensland, the AMC understands that the Medical Board is not able to take action, unless the practitioner is currently registered.

3. The Berg case again raises the issue of 'flagging' entries on the NCMR. Although there appear to have been concerns about the authenticity of Dr Berg's qualifications for some time, and the specific issue of forged documents was raised by the College in October 2001, his entry on the NCMR is not flagged. As a result other Boards are not aware of the potential problem with Dr Berg.

The incidence of fraudulent qualifications is not large. Since 1993 when the current process for specialist assessment was introduced on a national basis some 1,600 applications have been processed. In this time there have only been 3 cases of suspected forged or misleading documents brought to the attention of the AMC. However, this may not be indicative of the extent of the problem, since not all Colleges apply the same rigour to establishing the veracity of the relevant qualifications as the RANZCP. While the numbers may not be significant, the adverse impact on the credibility of the registration process needs to be addressed.

This is my answer to the questions of one newspaper:

"Thank you for contacting me and for your effort to bring public attention to the event of the deaths of 3 mental health patients in Townsville. I do hope your interest will stimulate a proper professional and broader investigation of these deaths.

As I have told you, Clozapine is quite a dangerous drug, but its use is strictly regulated by instructions of Novartis, company-producer, and by well established medical experience and control procedures. Generally speaking, it is safe to use Clozapine for appropriate patients under appropriate instructions and medical experience. Deaths from Clozapine, although occurred, are quite rare. Therefore, three recent deaths in Townsville arise as something extraordinary in the death statistics from Clozapine. And I believe that Clozapine is not the first one to blame for these deaths. It is crucial to answer the question: why it has happened in Townsville and why so many patients have died here. All the abovementioned give no choice but to suggest that something has been wrong within Townsville Integrated Mental Health Services. My strong belief, as an Australian citizen and medical practitioner, is that this obvious possibility must be professionally and broader investigated, and all the necessary actions to improve mental health services in Townsville must be taken.

My opinion is that poor professional and managerial qualifications of Drs. Allan and Boyes have lead, possibly, indirectly, to these deaths. To support this, I am prepared to supply professional investigation with the appropriate examples of my professional disagreements with Drs. The latest news from Townsville Mental Health are very alarming: some patients have died after inappropriate psychiatric treatment. The attention of media and public to this horrible event gives hope that it will be fully and professionally investigated.

I would like to express my opinion that Dr. John Allan, Director of Integrated Mental Health, and Dr. Sharon Boyes, Clinical Director of Acute Care Unit, should take full responsibility for the deaths of patients. My disagreements with Dr. Sharon Boyes about the practice of Clozapine use, particularly, in cases of two patients from Kirwan Rehabilitation Unit, were totally ignored by her. Without any professional consideration, she was supported by Dr. John Allan. Moreover, they considered my opinion as a professional challenge to them and started to persecute me. In their reports to Queensland Health and other relevant authorities, they have spread defamation about my qualifications and professional performance, not supported by any legal evidence. Now, I have certain reasons to believe that the influence of such a defamation on the AMC and RANZCP allow to suspect some prejudicial approach to the assessment of my professional qualifications and experience. So, there is a possibility that the poor professional and human qualities of Drs. Allan and Boyes can lead not only to the deaths of patients. I see my duty as a medical professional, familiar with the situation, to report my knowledge about poor professional and managerial qualifications of Drs. Allan and Boyes to relevant authorities. To prevent further maltreatment and deaths of patients, I would like to be questioned by authorities on this topic. I am expecting to be contacted by all the parties involved.

I refer to your application for assessment for recognition as a medical specialist by the AMC/Specialist Medical College procedure.

The AMC has been advised by the Royal Australian and New Zealand College of Psychiatrists (RANZCP) that the Training and Examinations Exemptions Sub-committee formally considered your application for specialist assessment/advanced standing on 20 September 2001.

You stated in your application to the AMC and the RANZCP that you obtained your primary medical qualifications (1975) and your Doctorate of Medicine in Psychiatry (1977) from the Voronezh State University in Russia. Your submitted qualifications are in the name of Techkaline Victor Vladimirovich – which, in your Statutory Declaration dated 1 August 2001 – you stated you changed to Vincent Victor Berg.

As part of the RANZCP's standard assessment process, an applicant's overseas psychiatric qualifications are confirmed with the relevant College/University or Authority. In the case of your application, the email address of the Voronezh State University in Russia was obtained and the University was contacted to confirm your qualifications in Psychiatry (in the name of Dr Techkaline).

The Voronezh State University replied, informing the RANZCP that the University did not produce diploma number 723438 "Medical Degree in Psychiatry" and, moreover, the educational program stated was not in existence in 1977. The Voronezh State University requested from the RANZCP faxed copies of Degree M-I No. 723438 "Medical Doctor in Psychiatry" and Degree MC XII No. 14211 "Candidate of Sciences in Psychology" for review.

After review of the qualifications, as faxed, the Voronezh State University emailed the RANZCP, stating that the documents were crude forgeries. The Voronezh State University confirmed this statement, by fax, on Voronezh State University letterhead dated 17 September 2001.

On the basis of the information obtained by the RANZCP from the Voronezh State University, it appears you have provided false documents in support of your application for specialist assessment/advanced standing.

You are reminded of the following statement, which is reproduced from page 25 of the AMC's *Information Booklet for Applicants – AMC/Specialist Medical College Assessment Procedures* Information 2001 Edition:

"Penalties for making False Declarations

- D28 A person who wilfully makes a false statement in a Statutory Declaration under the Statutory Declarations Act 1959, as amended, is guilty of an offence against that Act, the punishment of which is a fine not exceeding \$200 or imprisonment for a term not exceeding six months or both if the offence is prosecuted summarily, or for a term not exceeding four years if the offence is prosecuted upon indictment.
- D29 An applicant for specialist assessment who wilfully makes a false statement or provides false information in his/her Application Forms or in the documents attached may forfeit his or her eligibility to present for assessment or be accorded recognition by an Australian or Australasian Specialist Medical College, or be subject to de-registration (if registration has already been obtained) and/or other penalties as prescribed in the relevant State or Territory medical registration laws."

I invite you to put before the AMC any information or documentation that you consider relevant and that will assist the AMC and the RANZCP in taking a decision on this matter.

Your application for specialist assessment has been deferred by the AMC, pending receipt and consideration of the requested information or documentation.

Dear Mr. Frank,

Responding to your letter of 25.10.01, I have to stress my fervent protest against:

- 1. The action of the RANZCP, requesting information about myself from the Russian Federation.
- 2. Any consideration of any information about myself obtained from the Russian Federation.
- 3. Any decisions concerning myself on the basis of any information about myself received from the Russian Federation.
- 4. Any suspicions and accusations regarding myself on the basis of any information about myself received from the Russian Federation.

I base my protest on the following legal points:

1. I have been officially recognised as a political refugee by the Australian federal authorities and granted domestic protection. In my application to the AMC, I have provided certified copies of documents legally proving this. It is a violation of international laws and agreements about refugees as well as Australian laws to make any inquires about a refugee in a country of his/her origin without the consent of the refugee. I have never been officially asked for permission to contact the Russian Federation on my behalf and under no circumstances given any permission to do this. Moreover, in "Explanatory Notes" submitted with my application, I have clearly stated in special paragraph called "Security concerns, regarding contacts with Russian Federation": "I am not in a position to disclose the direct factors, threatening my life, and this cannot be the matter of the AMC consideration. My purpose is to inform you that I am trying to avoid any contacts with Russian Federation and even with Russian communities and persons of Russian origin in Australia. Thus, I am not in a position to give permission for any direct or indirect contacts with Russian Federation on my behalf." Yet, the RANZCP has contacted the Russian Federation without my permission, against

my will and despite my warnings. I consider this action as illegal, violating Australian and international laws and making considerable damage to myself. You write in your letter that "as part of the RANZCP's standard assessment process, an applicant's overseas psychiatric qualifications are confirmed with the relevant College/University or Authority". It is understandable. However, it is not only understandable, but also determined by the law that there are certain objective legal limitations in refugee's cases derived from a refugee status. In my letter of 19.07.00 to Mr. Peter Lindsay, Federal MP for Herbert, the RANZCP and Medical Board of Queensland (I enclose a copy of that letter), I have called an attention to the unintentional discrimination of refugees because of the limitation derived from their refugee status, for example, "the lack of professional referees reports from a country of origin, inability to make any inquires to any authorities or persons in a refugee's country of origin, and so forth". I doubt that "the RANZCP's standard assessment process", which you are referring to, should be outside or above international and Australian laws concerned and violate them. Therefore, I consider the RANZCP's action of contacting the Russian Federation without my consent as illegal and fervently protest against it.

2. According to the laws, concerning refugees, the legal recognition of a refugee status means an official acknowledgement by relevant authorities (in my case, Australian federal authorities) that a refugee was or has or could be illegally persecuted by the authorities of a country of origin with a real threat to refugee's life. Consequently, any inquires about a refugee from any authorities of a country of origin must not be made without a refugee's consent. No information obtained from these sources can be trusted and have any legal consequences. Therefore, I am officially stating that the information concerning myself illegally obtained by the RANZCP from the Voronezh State University must not be trusted and must not have any legal consideration and consequences. This information is false and should be viewed as non-existent within the assessment of my qualifications and experience. Besides, I would like to see any legal reasons officially stated by the AMC and RANZCP, according to which they must trust any Russian authorities widely known by their lies and disinformation, rather than myself. I would like to see any legal reasons officially stated by the AMC and RANZCP, according to which they must trust any Russian authorities, which have illegally persecuted me and have a certain interest in discrediting me, rather than myself. Plus, I have to address you again to the "Explanatory Notes" submitted with my application, where I mentioned that "I was selected to undertake an exclusive course, which was designed to prepare highly qualified physician-psychiatrists for a work in some special government departments, such as the Ministry of Foreign Affairs, Ministry of Defence, Ministry of Internal Affairs, and the KGB. This course offered the study of Medicine with major in Psychiatry, combining undergraduate general medical study with postgraduate psychiatric specialist training". I am not in a position to tell you more about this course, but can only stress again that it was a special course, and no authority in the Russian Federation would ever disclose any information about this course and its students even within Russia, particularly to a foreign country. For this reason, there are three possibilities why the authorities of the Voronezh State University has provided to the RANZCP disinformation about myself: (1) most likely, they do not have an access to the relevant information, and their disinformation has been sincere; (2) less likely, they have an access to the relevant information and lied intentionally; (3) possibly, they showed the RANZCP's request to the special

services, and they decided to use the opportunity provided by the RANZCP to discredit me.

According to the all above mentioned I insist that:

- ❖ I have not provided false documents in support of my application for specialist assessment/advanced standing – all the documents and information provided are authentic. I am prepared to sign a Statutory Declaration about this, if required.
- No information from the Russian Federation concerning myself must be requested and considered and has any legal significance and consequence.
- ❖ All the limitation derived from my legal refugee status must be accepted, and the assessment must be made on the basis of documents and information submitted as well as information obtained from my referees and within Australia.
- ❖ The RANZCP's mistake should be quickly corrected that the assessment would be finalised as soon as it is possible.

I would like to express hope that the AMC and RANZCP should have more reasons to trust the Australian government, which scrutinised me and accepted as a political refugee under its protection, rather than those Russian authorities against which the Australian government is kindly protecting me.

I would like to express hope that the AMC and RANZCP should have more reasons to trust fellows of the RANZCP Professor Philip Morris and Drs. Diana Hamilton and Ian Wilson as well as my referees Drs. Leon Petchkovsky, Brian Boettcher, and Barend Vorster consultant-psychiatrists, who evaluated my professional knowledge, experience and performance in Australia very positively, and not to make professional idiots of them rather than to trust those unknown to them Russian authorities discredited themselves in many widely known cases by lies and disinformation of the international community.

Finally, I trust that the AMC and RANZCP are parts of the Australian community and realise that their decision in my case will have significant social consequence. They should not step aside or arise above community, letting the government to deal with the life of 50-year-old psychiatrist, who has gone through so many hardships and is now unemployed and facing bankruptcy.

I am looking forward for your urgent help.

I write on behalf of the Fellowship Board Training and Examinations Exemptions Sub-committee regarding Dr Berg's application for specialist assessment/advanced standing. The Training and Examinations Exemptions Sub-committee formally considered this matter on the 20 September 2001.

Dr Berg stated in his application to the Australian Medical Council and the RANZCP, that he obtained his primary medical qualification (1975) and his Doctorate of Medicine in Psychiatry (1977) from the Voronezh State University in Russia. Dr Berg's submitted qualifications are in the name of Techkaline Victor Vladimirovich, which Dr Berg states in his Statutory Declaration dated 1 August 2001, he changed to Vincent Victor Berg.

As part of the standard RANZCP assessment process, applicants' overseas psychiatric qualifications are confirmed with the relevant College/University or Authority. The email address of the Voronezh State University in Russia was obtained via the internet and was contacted to confirm Dr Techkaline's qualifications in Psychiatry.

The Voronezh State University replied informing the RANZCP that they did not produce diploma number 723438 "Medical Degree in Psychiatry" and moreover the educational program stated was not in existence in 1977. The Voronezh State University requested faxed copies of Degree M-I No. 723438 "Medical Doctor in Psychiatry" and Degree MC XII No. 14211 "Candidate of Sciences in Psychology" for review, see attached email and facsimile to Sharon Rayner (trainee staff member) dated 10 and 17 September 2001.

After review of the faxed qualifications, Sergey Zapriagaev from the Voronezh State University emailed the College stating that the documents were crude forgeries, see attached email dated 11 September 2001. Faxed confirmation of this statement on Voronezh State University letterhead dated 17 September 2001, is also attached.



I refer to your recent application for specialist registration. At its meeting of 27 February 2001 the Medical Board of Queensland held an inquiry pursuant to Section 25A of the *Medical Act 1939*.

The Board reviewed the documents submitted in support of your application and the further material provided by you. This is my response to your letter of 05th of February 2001 confirmed that my application for the registration under Section 17C(e) of the *Medical Act 1939* to practise within the speciality of Psychiatry has been declined by the Board as I "do not appear to have Fellowship with the Royal Australian and New Zealand College of Psychiatrists".

I disagree with this Board's decision and am satisfied that, as your letter informs, "an Inquiry will be held on 27 February 2001 into [my] eligibility to be registered" under Section 17C(e) of the *Medical Act 1939* to practise within the speciality of Psychiatry. I am asking the Inquiry to recommend to annul Board's recent decision and to grant me the registration requested in my application.

I appeal against the Medical Board of Queensland decision to decline my application for registration under Section 17C(e) of the *Medical Act 1939* to practise within the speciality of Psychiatry as I "do not appear to have Fellowship with the Royal Australian and New Zealand College of Psychiatrists" for the following reasons:

- Medical Act 1939 is never referring to the fellowship of the Royal Australian and New Zealand College of Psychiatrists as to the essential criteria for the registration under Section 17C(e) to practise within the speciality. It is doubtful that the interpretation of law or established practice could be legally used as law's substitute.
- It is widely recognised that the practice to encourage, to accept, and to support any monopoly of any organization in

any area of public life as an alternative to healthy competition is socially and professionally harmful. Such a monopoly might be illegal under Australian law and could be a subject for investigation and actions by the Antimonopoly Committee headed by Prof. Phels. Therefore, Board's referral to the proposed monopoly of the Royal Australian and New Zealand College of Psychiatrists to have only its fellows registered in Queensland as specialists in Psychiatry looks inadequate. The practice to send an application for registration to 3 nominated specialists seems to be more reasonable. This possibility is present in the application form for registration; yet, my application has never been forwarded to the nominated specialists. Also, the Board could contact the Institute of Australasian Psychiatrists, which has elected me as its associate member in November 2000.

 I know quite a number of doctors registered in Queensland as specialists in Psychiatry and working as such who are not fellows of the Royal Australian and New Zealand College of Psychiatrists. Accordingly, to reject my application because I "do not appear to have Fellowship with the Royal Australian and New Zealand College of Psychiatrists" means to discriminate me.

My Curriculum Vitae and the reports of my Australian referees evidently show that I am highly qualified and experienced psychiatrist who proved to be able to work efficiently in Australian health system. My referees recommend me for a work on the specialist level and support my application for the registration as such. I cannot see any reasons why the Medical Board of Queensland should not trust my referees whom it itself recognises as specialists in Psychiatry and who know me the best professionally and personally.

I do hope that the Board will consider all these and the other reasons outlined in my application and will grant me the registration under Section 17C(e) of the *Medical Act 1939* to practise within the speciality of Psychiatry.





After the completion of high school, in September 1969, I entered medical faculty of the Voronezh State University as a full-time student in Medicine with major in Psychiatry. Its combined graduate and postgraduate course had been fully completed by myself. I also fully completed the medical-psychiatric internship and submitted research thesis on the topic "Schizophrenia as A Cause of the Alienation of Personality from Society and of the Antisocial Behaviour". In May 1977, I had been awarded the degree of Doctor of Medicine in Psychiatry. Continuing my postgraduate study, from May 1977 to December 1978, I had undertaken a research in Psychology on the topic "The Alienation of Personality From Society as A Cause of Antisocial Behaviour". After the completion of this research, I had been awarded the research Degree of the Candidate of Sciences in Psychology, which is equal to Australian PhD.

Since January 1978 until April 1982, I had been working as a full-time lecturer and senior lecturer in Abnormal Psychology at the medical faculty of the Voronezh State University. Also, since January 1978 until August 1986, I had been working as a part-time psychiatrist in the psychiatric clinic of the State Department of Health. In April 1982, I had been ordained a deacon in the Russian Orthodox Church. In June 1982, I had been ordained a priest. In June 1986, I had been consecrated as a bishop. In August 1986, the KGB illegally arrested me for my political and religious beliefs. In January 1988, I had been released from the KGB prison. However, I was not allowed to practice officially as psychiatrist and priest. I had been working as a priest in the underground Church and practising privately and secretly as a psychiatrist.

The communist authorities tried to stop my activities. The

persecutions forced me to leave the country of my birth. In December 1992, I arrived in Australia.

All my circumstances and documents were checked and approved by the Australian Federal authorities. In October 1993, I was recognised by the Australian Federal Government as a refugee for political reasons and gained domestic protection. By that time, I rejected Russian citizenship. In June 1994, I was granted permanent residence in Australia, and, on the 30th of October 1996, --Australian citizenship.

I arrived in Australia with my son. As a sole parent, I was granted pension by the government. For the last 6 years, I dedicated my time to my son, looking after him, and to a private research on suicide.

From August 1999 to November 1999, I had been practising as a Clinical Observer in Psychiatry in the Gold Coast Hospital. In October same year, I had been granted conditional registration with the Medical Board of Queensland. Since the 10th of January 2000, I have been working as a Registrar in Psychiatry (non-training position) in the Community Mental Health Services, Townsville. In November 2000, I have been elected an associate member of the Institute of Australasian Psychiatrists.

I have worked with Vincent Berg for several months since starting work in Townsville as the Director of Forensic Mental Health Services, Northern Zone. He has been sharing the same rooms as myself and I have been supervising him from time to time and discussing patients with him.

He clearly has considerable experience in Psychiatry and I have examined his original Russian credentials together with certified copies in English of these credentials and they all seem perfectly in order to me. He also showed several papers that he has written together with a paper that he had done on suicide, which I would believe, is at PhD standard and is about 85,000 words long. The work itself is extremely good and it is an excellent review of suicide together with some original thoughts on this subject.

He has a degree in Russia which would qualify him in Australia I believe, as a Consultant Psychiatrist as well as having medical and psychiatric qualifications, he has also obtained a PhD in Russia. His English is good and he relates well to patients. I believe he should be working in Australia as a Consultant Psychiatrist level.

Added to all this, is the incredible hardship that he suffered in Russia after he was persecuted for political reasons and was eventually accepted in Australia as a Political Refugee. I believe he has much to teach us about Psychiatry as performed in Europe and it would be a considerable loss if people such as him are not recognised as specialist Psychiatrists in Australia with his very considerable experience.

Dear Dr Berg

I acknowledge your letter of 21 July 2000 directed, amongst others, to the Medical Board of Queensland.

You have pointed to alleged inconsistencies in your circumstances compared with those of another unnamed overseas trained psychiatrist. It would not be possible to respond further to your assertions in this respect without knowledge of the full details.

From those details of your grievances and particular circumstances which you have provided, it is however clear that the issues raised may concern the relevant college and the employer, but not the Medical Board of Queensland.

According to the Board's records, you were offered a training position as a registrar in psychiatry with a one year posting at Townsville General Hospital, subject to obtaining appropriate conditional registration to undertake the offered training activity. Registration was subsequently approved by the Board, effective from 4 January 2000.

The Medical Board of Queensland administers the legislation which regulates the practice of medicine in this state. The Board must pursue its obligations under the legislation in an open and fair manner. Refusal of an application for registration is always notified to the applicant together with full reasons for the decision. Review and appeal processes are also available to unsuccessful applicants.

The Board is not able to exercise discretion regarding applicants such as on the basis of citizenship or refugee status. Indeed any such preference would be inequitable, and no doubt unlawful.

Unfortunately, your primary and specialist qualifications obtained in the former USSR do not entitle you to any form of registration in this State. Only conditional registration for a specific purpose such as, in this case, to undertake training approved by the Board is available to you.

The Board has a significant responsibility to ensure that applicants have met the legislative, training and entry standards necessary for registration. Applications are carefully scrutinised under open and fair processes. Your application was carefully considered and the category in which you are currently registered is that which is appropriate in your circumstances.

I trust that the above clarifies the position for you.
