## COMMISSION OF INQUIRY NO. 1 OF 2005 MEDICAL BOARD OF QUEENSLAND

This is the annexure marked "EMC-3" mentioned and referred to in the Statement of ERICA MARY COHN dated this 17<sup>th</sup> day of May 2005.

## 5. BOARD STRUCTURE

Section 15 of the Medical Practitioners Registration Act 2001, which commenced on 1 March 2002, provides that the Board shall consist of the Chief Health Officer and at least 6, but not more than 10, persons appointed by the Governor in Council. The appointed members must include persons who are registrants, persons having an interest in, and knowledge of consumer issues ("public members"), and a lawyer nominated by the Minister. None of the public members may be, or have been, registered as a health practitioner or as a nurse either currently or in the past in Queensland or elsewhere.

During the reporting period, 1 July 2002 to 30 June 2003, ordinary meetings of the Board were held twice monthly on the evenings of the second and fourth Tuesday of each month.
