Hi David

I have attached the full list of indicators used for the phase 1 reports.

With regards to the table on the progressive reduction of the indicators.

Was this the powerpoint slide that graphically showed the reduction? If so, I have included it within the presentation that you already have and attached (it is the 3rd slide into the 'Content' section) or are you wanting something more specific?

We did the presentation to the Minister & DG the Tuesday before last. They both seemed quite impressed by the work that had been done, but as expected were very concerned about the media consequences. As a result it has been decided that the reports should go to cabinet, specifically stating the purpose of the Public & Hospital reports (with the view that the DM's would be the only recipients of the hospital report). It is planned to go to cabinet on the 28th October 2002 (maybe a little earlier if we can swing it). I have contacted Prof Barraclough as a champion for the report and he has agreed. It has been a very busy period as we are trying to commence work for Phase 2 analysis at the same time. We have done this as we are concerned about the age of the phase 1 report and when we finally get it out, it would be good to have a second report (with refined indicators and trend analysis) available soon after.

Let me know if you need more detail about the progressive reduction of indicators and I will have a look to see what I can find?

Hope to talk to you soon (especially if I am able to send you a copy of the released public report
